- g. For interest, this was Captain Morten Kviem's report from III 4 WG 1. The correspondence group had made a very "solid" paper in III 4-4. A revised procedure for analysis was proposed, and it looked like a huge improvement from the present system. However, it soon became clear that a vast majority of the WG wanted even more significant changes. In a few words it can be described as shifting more of the effort from "Lessons Learned" to "Identification of safety issues". I support that in principle, but I also understand those who consider that suggestion to be outside of the TOR. The WG was even visited by the plenary secretary, Mr. Brice Martin-Castex, who strongly emphasized that "Lessons Learned" had to be part of the plans for the future. The WG ended up suggesting that "Lessons Learned" would be a responsibility for the reporting member state, as they were the ones with all information in the individual casualties. The CG and WG could then focus on finding trends and put together information from various sources assisting IMO in identifying safety issues and get those issues on the appropriate agenda. If this system is established, and it works, it will be a huge improvement.
